

## Historic North Venue Gateway BID #28 Improvement Grant Guidelines

The Historic North Avenue Gateway Business Improvement District (BID) #28 has established an Improvement Grant Application to assist the commercial property owners and businesses in BID 28 with improvements that will help improve the aesthetics of the BID area.

BID 28 has reserved \$10,000.00 per year for Business Improvement/Programming. These funds will be available on a first come basis per calendar year until all funds have been used. This grant is only issued as reimbursable funds.

## The Board of Directors of North Avenue Gateway BID 28 reserves all approval on awarding grants.

Here are some additional specifics on the BID 28 Grant process:

- Grants awarded will be up to \$250.00. Reasonable Reimbursements Needs
- Examples of eligible projects include but are not limited to: landscaping, permanent signage, façade enhancements, and security installments. Reimbursable grants may be used in combination with the City of Milwaukee of Milwaukee Department of City Development Façade Grant Program and /or Signage Grant Program.
- Awardees agree to work cooperatively with the City of Milwaukee Police Department on any and all security installations.
- All façade and signage improvements must be on the street facing side of the property and be in compliance with all City of Milwaukee zoning requirements and ordinances.
- Grants will only be given to properties that are not delinquent on the tax payments to the City.
- Only entities that are located within a commercial building that have paid into the BID assessment on the business corridor of North Avenue Gateway (west of 27<sup>th</sup> North Ave to Sherman Blvd.) can receive a grant.
- Each address in BID 28 is only eligible to receive one grant per calendar year.
- Grants awarded are reimbursable funds. The actual grant funds will be disbursed only
  after all documentation is approved including expense reports and photographs of the
  completed work.
- Following the approval, the applicant has 90 days in which to use the funds allocated. Failure
  to do request reimbursement within 90 days will mean the money allocated with go back into
  the program for reallocation to another participant.

The Historic North Avenue Gateway BID 28 board has the right to end this program and/or amend the guidelines at any time.
